You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

PLACEURO EURO HIGH YIELD (Part D EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The assets of this Sub-Fund shall be invested in: bonds or Eurobonds issued in EUR, listed on a stock exchange or listed on another regulated market, which operates regularly, is recognised and open to the public (e.g. ISMA); UCITS approved in accordance with Directive 2009/65/EC, up to a limit of 10% of its net assets. Whether they are bonds, convertible bonds or equities, the selection will be made on the basis of the quality of the management, the criteria of which are: liquidity, security for the monetary part; volatility of the net asset value, capacity of the manager to be regular in the performance, talent of the manager, recognition by his peers, nominations for major prizes, and track record for the other funds; in general: the quality of the management company; and in other transferable securities (with a maximum of 10% of the net assets). The Fund may use derivatives for hedging and investment purposes, including forward and futures interest rate and equity derivatives. The exposure to derivatives may not exceed 100% of the net assets on a commitment basis (i.e. underlying equivalent calculations).

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

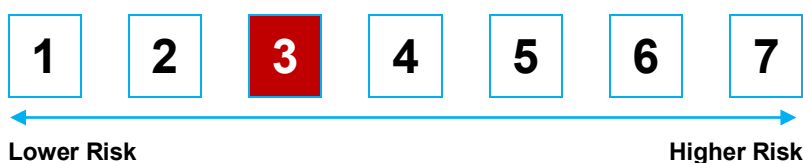
The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 3 out of 7, which is a medium low-risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies.

This risk is not considered in the indicator shown above.

You may lose up to the totality of the amount you have invested in the Fund.

What are the costs?

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does (where applicable). The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested minus the total costs (247.73 (€)), which has an annual cost impact of 2.48%.

How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. The price is based on the net asset value per Share of each class determined at the Valuation Point. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
