What is this product?

Type

PLACEURO GLOBAL INVEST (Part C EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The assets of this Portfolio will be invested: principally in equities and other equity-linked transferable securities (e.g. warrants, warrants) listed on any regulated market, in bonds, in bonds convertible into equities listed on a regulated market, in UCITS, provided that such UCITS are subject to permanent supervision in their country of origin by a supervisory authority provided for by law for the purpose of investor protection. These UCITS must also have as their principal object investment in shares, stock market or sector indices, bonds or other transferable securities. The Fund may also invest in other transferable securities (up to a maximum of 10% of net assets), money market instruments and cash. The Sub-Fund may use financial derivative instruments for hedging purposes, in particular authorised financial futures and/or options on indices, equities, interest rates, currencies, whether on regulated or over-the-counter markets, provided that the aggregate exposure does not exceed 100% of the assets.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

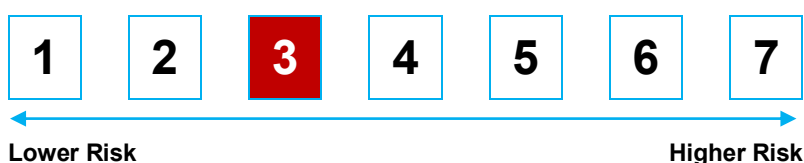
The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 3 out of 7, which is a medium low-risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

You may lose up to the totality of the amount you have invested in the Fund.

What are the costs?

We have assumed:

- In the first year you would get back the amount that you invested minus the total costs (235.02 (€)), which has an annual cost impact of 2.35%.

How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. The price is based on the net asset value per Share of each class determined at the Valuation Point. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
