What is this product?

Type

PLACEURO WORLD EQUITIES (Part C EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The assets of this Portfolio will be invested: mainly in equities and other equity-linked transferable securities (e.g. warrants, warrants) listed on any regulated market, in UCITS, provided that these are subject to permanent supervision in their country of origin by a supervisory authority provided for by law in order to ensure investor protection. These UCITS must also have as their principal object the investment in shares or in stock market or sectoral indices. Secondly in UCITS, provided they are subject to permanent supervision in their home country by a supervisory authority provided for by law for the purpose of investor protection. Such UCITS must furthermore have as their principal object the investment in bonds or other transferable securities, other transferable securities (with a maximum of 10% of the net assets), money market instruments, cash. The proportion of the Sub-Fund's net assets invested directly or indirectly in debt securities, money market instruments, deposits and cash and in structured products whose underlying assets consist of debt securities, money market instruments, deposits or cash will not exceed 10%. The Portfolio may use financial derivative instruments for hedging purposes, including authorised financial futures and/or options on indices, equities, interest rates and currencies, whether on regulated or over-the-counter markets, provided that the aggregate exposure does not exceed 100% of the assets.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

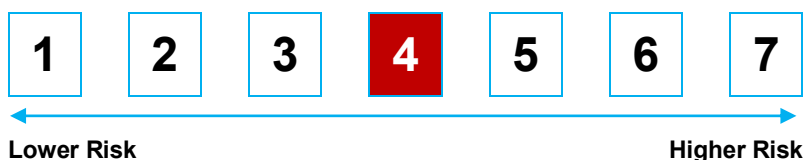
The Sub-Fund has been established for an unlimited period of time and is open-ended.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. You may lose up to the totality of the amount you have invested in the Fund. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment.

What are the costs?

We have assumed:

- In the first year you would get back the amount that you invested minus the total costs (252.09 (€)), which has an annual cost impact of 2.52%.

How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. The price is based on the net asset value per Share of each class determined at the Valuation Point. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
