What is this product?

Type

PLACEURO EURO CORPORATE BONDS (Part I DIS EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The assets of this Sub-Fund will be invested: mainly in Investment Grade corporate bonds issued in Euro and, on an ancillary basis, in Investment Grade government bonds issued in Euro, in non-investment grade or unrated corporate bonds issued in Euro or in foreign currencies, in UCITS, provided that these UCITS are subject, in their country of origin, to permanent supervision by a supervisory authority provided for by law with a view to ensuring investor protection. Such UCITS must also have as their principal object investment in bonds or other transferable securities, other transferable securities (up to a maximum of 10% of net assets), money market instruments, cash. The Sub-Fund may use financial derivative instruments for hedging purposes, in particular authorised financial futures and/or options on indices, equities, interest rates, currencies, whether on regulated or over-the-counter markets, provided that the aggregate exposure does not exceed 100% of the assets.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator





The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 2 out of 7, which is a low-risk class. This rates the potential losses from future performance at a low level, and poor market conditions will likely impact the Fund's capacity to pay you.

What are the costs?
