What is this product?

PLACEURO - CLASSIC (Part C EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The Portfolio will invest principally in: bonds, including treasury certificates, issued by an Investment Grade country within the Eurozone or bonds of Investment Grade issuers. The Portfolio will invest on an ancillary basis in bonds: issued or guaranteed by OECD and non-OECD countries, listed or traded on a regulated market which operates regularly and is recognised and open to the public; issued by local authorities or by companies, listed or traded on a regulated market which operates regularly and is recognised and open to the public. The choice of investments will be limited to a maximum of 50% in currencies other than the Euro. The primary objective of this Sub-Fund is the optimisation of the return taking into account the security of the capital, the stability of the value of the assets and a high liquidity ratio.

Intended investor

The Sub-Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

The Recommended Holding Period of the product is 5 years.
