What is this product?

PLACEURO BG OPPORTUNITES (Part C EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The assets of this Portfolio will be invested in whole or in part in equities listed on all international stock exchanges or regulated electronic quotation systems, bonds or Eurobonds issued or guaranteed by borrowing countries, whether or not members of the OECD, listed on a regulated market, bonds or Eurobonds issued by local authorities, by companies listed on a regulated market, convertible bonds or eurobonds issued by companies whose shares are listed on a regulated market, up to 50% of its assets in units of UCITS pursuing equity strategies or other bond, mixed or money market investment strategies. The Sub-Fund may also invest in: financial futures instruments traded on regulated or over-the-counter markets (such as repurchase agreements, interest rate swaps, index swaps, currency swaps, currency futures and options on equities, interest rates, currencies or indices) in order to pursue its investment objective, high yield bonds (up to a maximum of 20% of the net assets), other transferable securities (up to a maximum of 10% of the net assets). The objective of the Sub-Fund is to seek performance by investing in the equity, bond and fixed income markets through management based on financial analysis. The direct and indirect exposure to the equity markets will not exceed 100%.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

The Recommended Holding Period of the product is 5 years.
