You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

PLACEURO DOM ASSET SELECT (Part A EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The management objective of this sub-fund is to offer a diversified and flexible management on the equity and fixed income markets in order to increase the value of your investment over the recommended holding period. For information purposes, exposure to the equity markets, regardless of sector or capitalisation type, represents between 0% and 100% of the assets, with the balance invested in the bond market, regardless of the type of bonds sought. The sub-fund may invest in developed markets as well as in emerging markets for diversification purposes. The Fund will seek to reduce overall risk and achieve an average annualised volatility of approximately 10% over a 5 year cycle. The investment strategy is systematic and is based on a portfolio management process organised around two pillars: The strategic exposure between equities and bonds varies significantly depending on the market situation. If the investment environment deteriorates, the model reduces the risk in the portfolio by reducing the exposure to equities. When the investment environment improves, the model increases equity exposure; and tactical exposure within asset classes varies significantly based on a number of indicators (macroeconomic, trend, timing) to take advantage of market opportunities. As part of its portfolio diversification objective, the sub-fund may invest up to 100% of its assets indirectly via UCITS, index-linked UCIs and/or trackers whose purpose is to invest in equities and/or bonds and to replicate indices representative of the various equity or bond asset classes. The management team selects the various underlying investments in order to create a portfolio in line with the investment objectives.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

You may lose up to the totality of the amount you have invested in the Fund.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If the Fund is not able to pay you what is owed, you could lose your entire investment.

What are the costs?

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does (where applicable). The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed: In the first year you would get back the amount that you invested minus the total costs (342.98 (€)), which has an annual cost impact of 3.43%.

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
