What is this product?

Type

PLACEURO DÔM PERFORMANCE ACTIVE (Part F EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The investment objective of the Sub-Fund is to seek to outperform the Eurostoxx 50 Net Return, net of management fees, over the recommended investment horizon. In order to achieve the management objective, the strategy implemented consists mainly of discretionary and active management of asset allocation and positions on the equity and bond markets, through a dynamic and flexible selection of financial instruments directly (equities and similar securities, bonds and similar securities, financial futures, etc.), or indirectly via UCITS and/or UCIs. The main performance driver is exposure to the equity market. The Sub-Fund will invest mainly in equities of companies domiciled in an OECD country directly or indirectly through units of UCITS or other UCIs or in bonds and similar securities of investment grade issued by issuers domiciled in an OECD country (including convertible bonds) directly or indirectly through units of UCITS or other UCIs, up to 30% in emerging market equities directly or indirectly via units of UCITS or other UCIs, up to 30% in bonds and similar securities (EMTNs, BMTNs, etc.) of non-investment grade.) of the non-investment-grade category directly or indirectly via units of UCITS or other UCIs. Exposure to currencies other than the Euro may not exceed 50% of the net assets. The Fund may use derivatives for hedging and investment purposes including, but not limited to, futures and options on interest rates, bonds, equities and indices. The exposure to derivatives may not exceed 100% of the net assets on a commitment basis.

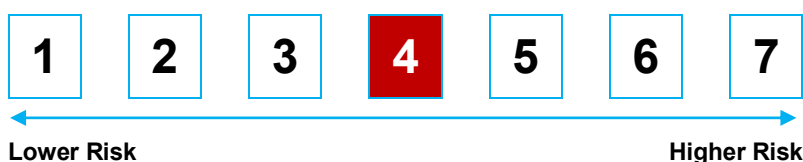
Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions will likely impact the Fund's capacity to pay you. **Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** You may lose up to the totality of the amount you have invested in the Fund. What are the costs?

We have assumed:

- In the first year you would get back the amount that you invested minus the total costs (126.72 (€)), which has an annual cost impact of 1.27%.

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
