#### What is this product?

#### **Type**

PLACEURO DÔM OPPORTUNITES 1 3 (Part I EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

#### Objectives

The investment objective of the Sub-Fund is to seek to outperform the EURO MTS 1-3 Year Index over the recommended investment horizon, while maintaining an interest rate risk exposure close to that of the index. In order to achieve the management objective, the Sub-Fund adopts an active management style in relation to its benchmark, in order to have a clear positioning in terms of risk universe and performance objective, while seeking to optimise the portfolio's risk/return profile in relation to its index. The reference to the FTSE MTS Eurozone Government Broad 1-3Y Index reflects the adoption of a risk profile corresponding to the portion of the curve used as a reference for the index. The Fund will invest: primarily in Investment grade bonds and negotiable debt securities or equivalent securities (including money market instruments) issued by Eurozone issuers; up to 20% in Investment grade convertible bonds issued by Eurozone issuers; up to 10% in bonds and equivalent securities issued by non-Eurozone issuers; up to 10% in UCITS or other UCIs; up to 10% in equities; up to 5% in non-investment grade bonds and equivalent securities. The Fund may also hold cash on an ancillary basis. Exposure to currencies other than the Euro may not exceed 50% of the net assets. The Sub-Fund may use derivatives for hedging purposes or to gain exposure to interest rate risk. The exposure to derivatives may not exceed 100% of the net assets on a commitment basis.

#### Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. Please refer to the Offering Document of the Fund for further details on closure of sub-funds.

The Recommended Holding Period of the product is 5 years.

# What are the costs?
