What is this product?

Type

Crediinvest Sicav – Fixed Income Dollar I3 is a Public limited company (société anonyne) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The main objective of the Sub-Fund is to achieve a high regular income while giving due consideration to capital security and to the liquidity of assets. Top priority from an investment policy viewpoint will be attached to diversification of the Sub-Fund's portfolio, issuer quality and maturity structures in line with interest rate expectations. The Sub-Fund invests its net assets within the scope of investment policy, where at least 80% of its total net assets are invested in fixed income securities, such as bonds, notes and other fixed-income and floating-rate secured or unsecured transferable securities (including floating rate notes, convertibles bonds and warrants issues whose warrants entitle the holder to subscribe transferable securities) and up to a maximum of 10% of the Sub-Fund's assets in shares or units of UCITS and/or other UCIs. The Sub-Fund may invest up to 10% of the net assets into contingent convertible bonds. Investment in cash should not exceed 20% of the Sub-Fund's net assets, while investment in assets other than those listed in the above paragraph should not exceed 10% of the Sub-Fund's net assets, and should be limited to ensure that the 80% minimum investment in fixed income securities is always respected. No equity exposure is allowed, whereas equity convertible securities are permitted to a limit of 20% of the Sub-Fund's net assets. Asset backed/mortgage-backed securities are permitted and may be held up to a maximum of 20% of the Sub-Fund's net assets. The Sub-Fund will invest in government and corporate bonds, including a maximum of 30% of its net assets in emerging market bonds, with a maximum exposure of 30% of its net assets to non-investment grade bonds of which a maximum 10% of the Sub-fund's net assets can be emerging market bonds. The Sub-Fund will invest at least 70% of its total net assets in investments denominated in USD.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. Please refer to the Offering Document of the Fund for further details on closure of sub-funds.

The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. This rates the potential losses from future performance at a low level, and poor market conditions will likely impact the Fund's capacity to pay you. Be aware of currency risk.
