What is this product?

Crediinvest Sicav – US American Value I2 HC is a Public limited company (société anonyne) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The main objective of the Sub-fund is capital appreciation, which it will attempt to reach by investing in transferable securities issued by US companies. According to the principle of risk diversification, the Sub-Fund's net assets are mainly invested in shares and other transferable securities related to share markets (including warrants on transferable securities, convertible notes and up to a maximum of 10% of the Sub-fund's net assets in shares or units of UCITS or other UCIs, whose assets are mainly invested in shares issued by US companies). However, in case of unfavourable share markets, the Sub-Fund's assets can be temporarily invested in less volatile assets, such as bonds or liquid assets, while preserving the Shareholders' interest. On a temporary basis and if justified by the market conditions, the Sub-Fund may hold liquid assets up to 100%. Moreover, the Sub-Fund may invest in financial derivative instruments or conduct transactions involving options on securities for hedging or investment purposes. The Sub-Fund may invest up to 10% of the net assets into contingent convertible bonds.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.


What are the risks and what could I get in return?

The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products.
