What is this product?

Crediinvest Sicav - Short Term Fixed Income Euro Fund Class C is a Public limited company (société anonyne) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

The main objective of the Sub-Fund is to achieve a regular income whilst aiming at reducing capital loss. The Sub-Fund invests its net assets within the scope of investment policy, where at least 80% of its total net assets are invested in fixed income securities such as bonds, notes and other fixed-income and floating-rate secured or unsecured transferable securities (including commercial papers, floating rate notes, convertibles bonds and warrants issues whose warrants entitle the holder to subscribe transferable securities) and up to a maximum of 10% of the Sub-Fund's net assets in shares or units of UCITS and/or other UCIs. Investment in cash should not exceed 20% of the Sub-Fund's net assets, while investment in assets other than those listed in the above paragraph should not exceed 10% of the Sub-Fund's net assets, and should be limited to ensure that the 80% minimum investment in fixed income securities is always respected. No equity exposure is allowed, whereas equity convertible securities are permitted to a limit of 20% of the Sub-Fund's net assets. Asset backed/mortgage-backed securities are permitted and may be held up to a maximum of 20% of the Sub-Fund's net assets in government and corporate bonds, including a maximum of 30% of its net assets in emerging market bonds, with a maximum exposure of 30% of its net assets to non-investment grade bonds of which a maximum 10% of the Sub-Fund's net assets can be emerging market bonds. The Sub-Fund may invest up to 10% of the assets into contingent convertible bonds. The Sub-Fund will invest at least 70% of its total net assets in investments denominated in EUR. The Sub-Fund can be classified as a short-term bond fund as it may have an average modified duration lower than 3 years.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.


The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?



Lower Risk



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 2 out of 7, which is a low-risk class. This rates the potential losses from future performance at a low level, and poor market conditions will likely impact the Fund's capacity to pay you. **Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** You may lose up to the totality of the amount you have invested in the Fund. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment.

What are the costs?

These amounts depend on how much you invest, how long you hold the product and how well the product does (where applicable). The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

• In the first year you would get back the amount that you invested minus the total costs (93.71 (€)), which has an annual cost impact of 0.94%.

How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day. Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
