What is this product?

Type

Credit Andorrà Global Investment Fund Sicav-Sif - Best Managers Value Fund Class B (USD) Cap is a Partnership limited by shares (société en commandite par actions) organized under the laws of the Grand Duchy of Luxembourg and having the status of a specialized investment fund under Part II of the SIF Law (13 February 2007).

Objectives

The Sub-Fund invests in a diversified portfolio of hedge funds but also in a range of traditional asset classes directly or indirectly. The Sub-Fund may also use Derivatives for hedging and investment purposes.

Intended investor

The Sub-Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

What are the risks and what could I get in return?

Risk Indicator





The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 5 out of 7, which is a medium high-risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
