What is this product?

Type

Tailored Fund - Global Absolute Return Class B (EUR) Cap is a Public limited company (société anonyme) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

Objectives

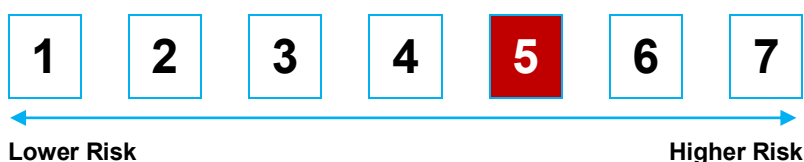
The objective of the Sub-Fund is to achieve on a yearly basis, positive returns under any market conditions. For that purpose, the Sub-Fund may invest its net assets, directly or indirectly (through UCITS or other UCIs) in (without any geographical restriction): equities, equity-linked securities, fixed income securities, depository receipts, warrants and other participation rights and participation notes, equity linked notes; debt securities, including fixed or floating rates, convertible bonds, zero-coupons, government and treasury bonds, without limits of duration and grade and up to 10% of the assets into contingent convertible bonds; financial derivatives instruments, listed on a regulated market and/or over the counter (OTC), for both investment purposes and hedging of portfolio risks; Money Market Instruments, term deposits and liquid assets mainly denominated in EUR, USD, JPY, CAD, NOK, SEK, CHF and up to 40% of its net assets denominated in other currencies. In order to achieve its objective, the Sub-Fund may assume a short exposure to individual securities or to selected equity markets through the use of financial derivatives instruments, either with underlying securities or with underlying equity indexes. The resulting total net exposure of the Sub-Fund to equity securities, directly or indirectly through the use of financial derivatives instruments, may vary between -100% and +100% of the Sub-Fund's Net Assets Value. The total net equity exposure of the Sub-Fund varies depending on the assessment of prospects of the general equity markets and of individual securities.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. Please refer to the Offering Document of the Fund for further details on closure of sub-funds.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 5 out of 7, which is a high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. **Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** You may lose up to the totality of the amount you have invested in the Fund. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment.

Any loss you do suffer as a result of actions of the Manager or the Fund is not covered by an investor compensation or a guarantee scheme.

What are the costs?

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does (where applicable). The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested minus the total costs (202.71 EUR (€)), which has an annual cost impact of 2.03%.

How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. The price is based on the net asset value per Share of each class determined at the Valuation Point. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
