### What is this product?

#### Type

GREEN BLUE FUNDS SCA SICAV-RAIF - GOOD GOVERNANCE FUND - Class SF (CHF) (the "Sub-Fund") of the "société d'investissement à capital variable - fonds d'investissement alternative réservé" denominated Green Blue Funds SCA SICAV-RAIF (the "Fund"). The Fund is an open-ended investment company with variable capital established in the form of a "société en commandite par actions". The Fund is authorized under the Luxembourg law of 23 July 2016 related to reserved alternative investment funds as amended from time to time and qualifies as an Alternative Investment Fund under the meaning of the Luxembourg law of 12 July 2013 related to alternative investment fund manager.

#### **Objectives**

The investment objective of the Sub-Fund is to provide significant long-term value by investing in a well-diversified portfolio of S&P 500 stocks. By investing in well governed companies, the Sub-Fund aims to promote organisations that have a long-term vision, a social conscience, and that are better positioned to make a positive impact on the overall economy and society. Furthermore, the investment policy is premised on the principle of risk diversification. It seeks to achieve a long-term outperformance in comparison to the S&P 500 Total Return Index.

#### Intended investor

The Sub-Fund is suitable for well-informed investors within the meaning of article 2 of the Luxembourg Law of 23 July 2016 related to reserved alternative investment funds, and have the financial ability and experience to understand, the willingness to accept and the financial resources to withstand the risk of loss inherent to a well-diversified product.

## What are the risks and what could I get in return?

#### **Risk Indicator**





The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 5 out of 7, which is a medium high-risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

# What are the costs?

# How long should I hold it and can I take money out early?

Shares of any Fund shall be redeemed at the redemption price on each Dealing Day.

Redemptions of the applicable Fund shall be effected at the Valuation Point on the relevant Dealing Day. The price is based on the net asset value per Share of each class determined at the Valuation Point. Redemption requests received after the Dealing Deadline shall be treated as having been received by the following Dealing Deadline unless otherwise determined by the Company.
