## WHAT IS THIS PRODUCT?

## Type

FASANARA INVESTMENTS SA, SICAV-RAIF - FASANARA DIGITAL LENDING FUND - Class S-D H (USD) is a Public limited company (société anonyme) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

## Objectives

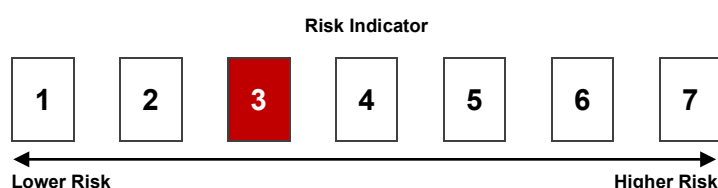
The Sub-Fund aims to generate long-term uncorrelated returns by investing in diversified alternative credit instruments, including trade receivables, invoices, and SME loans through digital originating platforms across the globe. It seeks to expand the global credit supply and become a reliable source of capital for SMEs and mid-caps, providing liquidity to the growing sector of digital receivables. The investment objective of the fund is to keep a certain degree of cash allocation and perform FX spot, forwards, NDF and FX options to hedge against foreign exchange risk. The fund is authorized to invest in financial derivative instruments for hedging or to achieve its investment policy, but not to diverge from its investment objectives. The fund also puts a strong emphasis on ESG factors when selecting investments and counterparties. The Sub-Fund is classified as promoting environmental or social characteristics but does not have sustainable investment as its objective (art. 8 SFDR).

**Intended retail investor**

The Sub-Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.

We have classified this Fund as 3 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you.

**Be aware of currency risk. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. ## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

This product is an open-ended fund but it is recommended to hold the product at least until the end of the recommended holding period. The product may be redeemed on a quarterly basis following the end of the Lock-up period. Any redemption request must be received no later than 5.00 p.m. (Luxembourg time) by the central administration ninety (90) calendar days preceding the applicable valuation day (the "Valuation Date"). All payments due pursuant to the foregoing will be paid within a reasonable time period, which in principle should not exceed one (1) month from the Redemption Day. The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.
