## What is this product?

#### Туре

Creand Global Investment SICAV-SIF - Crèdit Andorrà Select Private Equity Fund Class (EUR) Cap is a Public Limited Company (*société anonyme*) organized under the laws of the Grand Duchy of Luxembourg and having the status of a specialized investment fund under Part II of the SIF Law (13 February 2007).

#### Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

#### Objectives

The Sub-Fund's objective is long-term capital appreciation through investing in private equity funds. Private Equity Funds hold private investments in operating companies' equity securities. Different strategies, including venture capital, mezzanine, buyout, international, and special situations, will be pursued. Diversification will consider strategy, geography, industry, investment size, and vintage year. Borrowing, issuing debt, and security are possible. Derivatives may be used for hedging. The Sub-Fund may concentrate assets in collective schemes with similar diversification rules. Investments will be managed based on opportunities and objectives. Cash management may involve liquidity funds. Sustainability risks are considered but not formally integrated into investment decisions. Environmental, social, and governance (ESG) factors are for informational purposes only. The Sub-Fund's investments do not align with EU criteria for environmentally sustainable activities.

#### Intended investor

The Sub-Fund is limited to Eligible Investors: Well-Informed Investors and non-Prohibited Investors. Prospective investors must provide required information, documents, and affidavits to demonstrate eligibility. Well-Informed Investors include institutional, professional investors, or those investing at least EUR 125,000, supported by relevant assessments. Directors and managers fall under this category. The Fund may refuse Shares, rights, or redeem Shares held by Prohibited Persons as defined by the Offering Memorandum, seeking indemnification except in cases like inheritance.

The Recommended Holding Period of the product is 7 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. ## How long should I hold it and can I take money out early?

You can't withdraw your investment before the lock-up period of 7 years since your subscription. After that, you have the right to redeem your shares on each Redemption Day. The redemption price will be based on the Net Asset Value of the shares at the Valuation Day. If you redeem within 7 years, no redemption is allowed, and between 7 and 10 years, a 25% charge applies. After 10 years, no charge applies. The Board of Directors can waive these periods and charges. Payment will be made within a reasonable time.
