You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as a Specialised Investment Fund (SIF) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The Sub-Fund's investment objective is to preserve capital over a 12-month period (absolute return) and keep volatility low. It invests primarily in undertakings for collective investment running absolute return and arbitrage strategies across liquid traditional and alternative assets like equities, foreign exchange and commodities. The goal is to build a portfolio of uncorrelated liquid arbitrage strategies and use proprietary tools to weight and time them depending on market conditions, to achieve true diversification regardless of market fluctuations. On an ancillary basis, the Sub-Fund may hold cash, cash equivalents and ancillary liquid assets. The Sub-Fund does not have sustainable investments or ESG characteristics as objectives.

Intended investor

The Sub-Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. Please refer to the Offering Document of the Fund for further details on closure of sub-funds.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

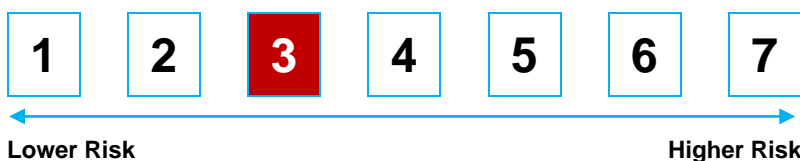

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this

Fund as 3 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. You may lose up to the totality of the amount you have invested in the Fund. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment. The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, credit risk, counterparty risk, operational risk.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performances of the product over the last 10 years, by identifying, depending on the performance scenarios and as defined in Regulation (EU) 2021/2268, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of 10 years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than 1 year, which end at the end of that period of 10 years. Markets could develop very differently in the future.

Cost over time

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario;

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 3 years. This product is designed for long-term investment; shares can be redeemed monthly at the end of a month and require a 65-calendar day reimbursement notice. An early redemption fee of 1% applies if the product is redeemed within 6 months.
