You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as a Specialised Investment Fund (SIF) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The Sub-Fund aims to build a diverse portfolio investing in liquid multi-strategies in global commodity markets for diversification and protection against volatile financial markets. It seeks out top investment managers to exploit inefficiencies in commodity and related markets using derivatives and equity instruments. Invests in uncorrelated absolute return and arbitrage strategies. Holds cash, cash equivalents, and short-term overlay instruments up to 20% of NAV. Must invest in EU or equivalently regulated depositaries and limits investment in single target fund to 25%. Not focused on sustainable or ESG investments.

Intended investor

The Sub-Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. The Recommended Holding Period of the product is 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Fund as 4 out of 7, which is a medium-high risk class. You may lose up to the totality of the amount you have invested in the Fund. Be aware of currency risk. Performance Scenarios
