

## **MC Square and GemCap Join Forces in Strategic Cross-Border Partnership**

The combined group will expand its management company, distribution, and operational services for asset managers and investors across the EU. ### **Regulatory Process Completed**

The deal has now been cleared by the Central Bank of Ireland, and noted by the FCA and the CSSF.

### **Client Continuity and Enhanced Capabilities**

Following completion, clients will be offered expanded access to cross-border expertise, a broader product suite, and enhanced fund distribution support. The group will maintain offices in Luxembourg and Dublin, leveraging local insight while aligning governance and operations. Offices in London and Chicago will also continue supporting local service providers and clients.
